Furthermore to my email yesterday

1. **Rules for branch league** these are the same rules and are the only rules for Nasinu Muslim Schools. There are no separate rules apart from the rules I have sent you and there are no separate constitution. The constitution I have provided is the sole and exclusively for Nasinu Muslim Schools only.
2. The same branch league constitution which I have sent you has been in place for Nasinu Muslim Schools for last 50 years.
3. Nasinu Muslim Schools or the properties of Nasinu Muslim League since its formation and later was affiliated with Fiji muslim League under a common constitution.
4. Under the common constitution all Muslim schools are running.
5. There are no separate set of constitution for Muslim schools.
6. As I have stated earlier the same branch league constitution has to be followed to run Nasinu Muslim Schools.
7. A set of elected officials with 2 officials from Fiji Muslim League are to be in the board to run the school.
8. All financials of the schools has to be passed in the branch league annual general meeting.
9. This practice has been followed for last 50 years.
10. So on what basis there was changes since last 4 years and the Ministry is accepting it.
11. The councils is not functioning, corrupt, and consist of unofficial members.
12. Nasinu branch league or the Nasinu Muslim school management has 11 motion before the council of Fiji Muslim League (regarding school issues) but till date the motions were not tabled by the Muslim league council.
13. The whole world knows Fiji Muslim League council is totally corrupt and they can't face Nasinu Branch League.

Bottom line the past 4 years financials you have for Nasinu Muslim Schools are to be approved in Nasinu Branch League (School Management) AGM. Then only the financials are legal.

Boso we will be here today and tomorrow we won't be here the procedures of the school management and of course the most important the procedures of the Ministry of Education has to be followed with no leeway.

I can write many more things almost 3 million dollars of funds mishandled by Fiji Muslim League management in particularly the self claimed president Hafiz Khan where he pocketed almost a million out of that all other corruptions are before FICAC but unfortunately they are still sleeping God knows one day they will wake up and do the investigation. But at east we all can try and build a better Fiji for our kids.

There must be some misunderstanding on this issue. You did sent me copy of RULES FOR BRANCH LEAGUE and not the School Constitution as claimed.FURTHERMORE, the financial report submitted to this office is an audited one conducted by a reputable Chartered Accountant as earlier mentioned in my last email to you. According to the School AGM report the Audited school financial report was presented to the public, moved by one Mrs Hamidan Hanif and seconded by Br Altaf Hussein.To that effect both schools has fulfill the laid down criteria of this ministry and that gave rise to the release of the school grants to Nasinu Muslim College/Primary respectively.
