RE: IM/P/10-07 – Maulana Mahmediran Patel

With response to the letter addressed to Mr. Patel advising him of his work permit being null and void, please be informed that the reasons given by you is quite contradictory to the reasons that you had given to us in the initial stages of this situation.

You had advised us on the 4th of this month that the Immigration Department is making his work permit null and void because of the fact that Fiji Muslim League had terminated the work contract of Mr. Patel and as such Mr. Patel becomes an illegal immigrant. You had also advised us that you don't know Fiji Muslim League - Nasinu branch because Fiji Muslim League was the parent body and the work permit of Mr. Patel was issued to the General Secretary, Fiji Muslim League.

The content of the letter dated 11th August to Mr. Patel is rather opposite to all that you had said on the 4th of this month. It states that the reason for the work permit being null and void is because Fiji Muslim League, Nasinu branch has terminated the work contract. Please be advised that the work permit # 0361/07 was issued to the General Secretary Fiji Muslim league, as advised earlier, and not to Fiji Muslim League, Nasinu branch and as such his work permit cannot be considered as null and void on the termination and advice of Fiji Muslim League - Nasinu branch. The fact remains that you might have some personal interest and agenda while dealing with this case. Please address the error immediately as it will be one of the issues put before the court of law.


Your letter has also failed to advise Mr. Patels rights to appeal under this particular situation. It is also very unethical to issue 48 hour notice for removal as it is not sufficient enough to allow anybody to dispose or sell his belongings and to withdraw his provident funds and get proper clearance from the Reserve Bank of Fiji. Also don't forget that 48 hours notice for removal does not allows him a fair opportunity for any legal actions against his former employer.

Also be informed that defamatory proceedings are being prepared concerning the incorrect comments that you had made in the 6 o'clock news on 9th August. Lastly, I'd like to give you a personal advice, if you don't have the guts to accept what you have said and done, pleased think a million times the next time you wish to open your mouth.

Immaterial what the outcome of this matter, at the end of the day you will be the one held responsible for all these unethical practices.

Very desperately looking forward to meet you in the court of law.

EMPLOYMENT AGREEMENT

Whereas Nasinu Branch of the Fiji Muslim League (here in called 'the Branch ') is a Branch of Fiji Muslim League (here in after called League) whereas the Branch is committed to providing and rendering true Islamic values and service to its Muslim community in addition to all relevant means and options through the boundaries of the mosque ie. **The Koronivia Jame Mosque.**

In the fulfillment of the aims of the Branch is providing Islamic Religious Services and Education, the Branch is committed to employ a Cleric/Scholar at the Koronivia Jame Mosque referred to as the Pesh Imam Sahab, Maulvi Sahab or Maulana Sahab.

Now therefore, this agreement made this 02ND of August 2007 between the Fiji Muslim League Nasinu Branch

AND

BR. IMRAN PATEL - Pesh Imam of Koronivia Jame Mosque.

Now, this agreement provides as follows:

1. That the Pesh Imam represents that he is fully competent to lead all prayers, meetings/sessions and related Islamic religious activities at the Koronivia Mosque on day to day basis.
2. That the duration of this agreement will be 3 year; commencing on 11-04- 2007 and terminating on 31ST JANUARY 2010.
3. That the Pesh Imam shall be paid the Annual Salary of \$7000-00/ANNUUM and will occupy the Fiji Muslim League Nasinu Branch's quarters at the Koronivia Jame Mosque at no cost to service the religious / imamiyat duties at the mosque.
4. That the Pesh Imam shall work under the supervision and control of the Branch President in consultation with the Management.
5. That you shall participate in all programs organized by the Branch and accept to perform all duties at the Mosque.



6. That you shall at all time behave and practice the right tradition of Islam, be in Islamic attire and a role model for the Community at large.
7. That you shall lead daily Salaat at the mosque including Juma congregational prayers on Fridays and Taraweeh prayers during the month of Ramadhaanul – Mubarak and Eedain prayers.
8. That you shall at no times bring no dispute or create one within the Community/Branch organization or go against the codes and ethics of Islam or the protocols of the FML – Nasinu Branch's Constitution and guidelines.
9. That you shall be responsible of keeping and maintaining the mosque yard and property through means of cleanliness and hygiene.
10. That you shall not seek no favoritism of nay kind for him, friends and relatives but you shall present your conduct in the true and most just manner in accordance to the doctrines of Islam.
11. That you shall at all times participate, present and organize all means of dawah and propagation ie. Tableegi work at the mosque.
12. That the Branch shall carry out their assessment and if it proves to be unsatisfactory status, then the Branch shall take / instigate appropriate action.
13. That you shall at all times adhere, convey educate and propagate the Hanafi school of thought to your audience, thus, the tradition of AHLE-SUNNAH-WAL-JAMAA is maintained.
14. That the Branch shall terminate your service in light of any abuse of position and or insubordination.
15. That you shall conduct Quran reading classes on daily basis and conduct adult Arabic classes if needed.
16. That you shall conduct Quran daras at every Markas which is in the boundary of Nasinu Branch once in a week.
17. That in addition to any other grounds either contained in this agreement or by any other operation of any law this agreement may be terminated by either party, by giving one month notice or a months pay in lieu of notice signed by the parties after the contents have been read and explained by them in the language of Urdu.

Dear Brother Sadruddin Musa and all Muslim brothers concerned,

Assalamu-wa-alaikum.

Re: Facts on Maulana Imran Patels departure from Fiji.

I was handed over copies of email messages from yourself and Abdul Hakim (member of Fiji Muslim League) and I was requested by several brothers concerned to reply. For a start Abdul Hakim sacked staff of In land Revenue for allegations on corruption, one of the most corrupted members of FML where he is involved in various funds mismanagement. FML is the most highly corrupted organisation where the self claimed president Hafez Ud-dean Khan outright sells pork and alcohol in his business and is involved in almost 1 million dollars of FML fund Corruption. The so called Uloom board of FML is being labelled by Muslims of Fiji as munafiq board for being involved in promoting interest as a halal product and outright condemns the animal slaughter practice of Mohammed (SAW). The current corrupt regime of FML is nothing but a group of munafiqs, liars, misleaders where they have lead the Islamic Institute into bankruptcy, Samabula Mosque construction into a bankruptcy, the national zakaat account into a bankruptcy, the Islamic book shop into a bankruptcy, million dollars of Saudi Funds for scholarship into bankruptcy, the Samabula shopping complex to bankruptcy and I can keep on writing. On the annual general elections the current regime brought in thugs and one of the biggest 'gunder' of FML, the vice president Shafiullah Khan to bulldoze in the elections. Allah (SWT) is my witness for all above allegations and I have all documentary evidences on above allegations and there's absolutely no doubt I understand on the consequences of what can happen to me on the day of judgement if I lie. I believe I have forgotten to state that most of the officials of FML benefit the free hajj package given by the Saudi team and for your information last year Hafez Khan and his corrupt branch official Sikander of Ba Muslim League enjoyed the free Hajj package. No one can know what are the personal benefits to be a part of this current corrupt regime of FML.

On the event where Respected Uloom-e-dean Maulana Imran Patel was forced out of his job and unlawfully removed from the country and the facts are as follows:

- 1- Two advertisements were palced in the Fiji Times for vacancies- no locals applied only Maulana Imran Patel Applied.
- 2- This was discussed and resolved by executive of Nasinu Muslim League to employ Maulana Imran Patel on the conditions:
 - a- Maulana has to come and work for 3 months free of charge – which he did.
 - b- A notice has to be placed after three months for any objections which was done by the branch league.
 - c- The branch league later received no objection and offered Maulana Imran Patel a full time employment and then Maulana signed a full three year contract and left for India.

- 3- The branch league approached the management of FML for approval for Maulana's employment and later the management of FML made an application to the immigration and after all formalities Maulana Imran Patel was granted a Work Permit.
- 4- Also note the original contract was with the immigration department and a copy was with the management of FML and there was a computer copy in the branch league office.
- 5- Maulana arrived with his family with no problems Alhamdulillah and he started his work peacefully with 100% member support.
- 6- Since Maulana Imran Patel was very learned and experienced there was a growing threat by local molvis (self claimed Mufti's) that if Maulana Imran Patel stays and the way he was promoting dean of Allah (SWT) in the correct manner and the most important Maulana Imran was the only Uloomah landed in the country had the greatest knowledge of tafseer-e-Quran. Not forgetting the most important thing was sister Aleema where she was doing a tremendous job amongst our sisters and mothers and local molvis was seeing this as competition.
- 7- Some 12 months back at a council meeting in Lautoka the most respected member of FML brother Afzal Khan was unlawfully removed as the speaker of FML and the two children's of convicted Amina Koya, Faiyaz and Faizal Koya was unlawfully part of the council where they allowed the unelected general secretary of FML munafiq Tabeez Akbar to allege us on 47 counts of corruption which was a total lie. Later at a council meeting a conspiracy took place against us by the corrupt regime of FML and we were removed out of the meeting and labelled as unbecoming Muslims. We were not even given a chance to defend ourselves but Allah (SWT) knows the best. This has happened because in last two years we have hammered Hafez Khan and his corrupted officials in all council meetings on the above mentioned corruptions.
- 8- When they saw that they cannot win the war against us they have punished our respected uloomah Maulana Imran Patel.
- 9- After a letter from the Fiji Muslim League of his job termination in just two days I was able to get almost 9600 signatures out of almost 10,000 Muslims living in Nasinu area condemning the Maulana's removal. This clearly shows that Maulana was very popular and was the only uloomah in the country that had so many support (one can be wrong but 9600 can't be wrong).
- 10- The FML regime somehow persuaded the corrupted director of Immigration where the director unlawfully removed Maulana and on his actions the matter is with the Police department and Public Service Commission. Trust me I will drive the last nail on the coffin of the Director's employment.

On the allegation Abdul Hakim has made where he states:

- 1- That one inspector Hajji Shameem is the chair of the Masjid committee – this man Shameem has been declared a munafiq by the Muslims of Nasinu, he is not even a member of Nasinu Muslim League, he has never contributed a cent of money or time in the formation of Nasinu Muslim League. He is there for his own personal gain.
- 2- Maulana Shahim has also been labelled as a munafiq, he is barred to lead any salaah at Jame-Masjid Koronivia, he is barred to lead any Janaaza Naamaz for any Momeens, he plays lotteries, he charges almost \$200 to wash a dead Muslim body but unfortunately he is

protected by the King of Munafiqs Hafez Khan through above mentioned inspector shameem and Nausori Police Officers, matters are in Magistrate courts.

- 3- The interim committee is unlawful and as I have said earlier Muslims of Nasinu Support us not the interim committee. As we have almost 95% of signatories.
- 4- Abdul Hakim and his team forcefully wanted Maulana to teach in school during the day time and do his masjid duties as well where maulana refused that his contract does not say to do so and maulana also mentioned that any extra work if I carry out I have to be paid for as well. Since he was the least paid ulooma in the country.
- 5- This is a blatant lie that maulana switched on his mobile with Abdul hakim and his party for us to hear any meeting conversation and for this Allah (SWT) is my witness.
- 6- Where Abdul Hakim claims the night they had that meeting where all these discussions were that maulana demanded for extra wages and switched on the mobile phone in fact they tortured Maulana that night and forcefully took him after maghrib for a meeting in the school and trust me Maulana never told me about this I was told that night by the most respected and learned member for FML Marhoom Hajji Karmani Khan where we had a meeting for almost 3 hours at my house on the issue of Maulan Patel and unfortunately our respected brother died the second night and for this I have two witnesses brother Hajji Iqbal and Munaf. In that meeting John Ali also said he felt like murdering Maulana.
- 7- This is a blatant lie that Maulana ever discussed any issues with me on the issue of the new contract which Abdul Hakim wanted him to sign and the simple explanation is when Maulana was being forced to sign the new contract I was in India for six weeks. Allah is my witness that I was given a copy of the contract not by maulana by the elected president of Nasinu Branch Brother Hajji Mumtaz Gani.
- 8- Where he states that brother Feroz and his group – the fact is I was elected as the secretary of the Muslims of Nasinu still supports me as their secretary and my group is not small I have almost 95% support of Muslims in Nasinu.
- 9- Yes Maulana did tell us that he said in the meeting that send him back on the basis that he was being tortured and bullied in nearly every second and third day meetings. What else can a man say if he has been humiliated in many ways?
- 10- On the issue where he says "he believes he does not blame maulana but he thinks he was bolstered by the ousted" and he later claims that maulana did not support to collect zakaat. Why can't Abdul Hakim speak the truth in this matter, **the fact is it's the people who refuse to give zakaat and donations to this corrupt interim officials not only last year but the same happened this year.**
- 11- On the issue where Maulana wrote a note on a scrap paper for leave this is again a blatant lie, Maulana did apply for a leave in writing on a piece of paper not scrap paper and later he was granted leave but they bullied him by deducting his wages. Of course maulana may have cursed them. Just imagine if any individual had undergone those torturing what he or she may have done.
- 12- This was a blatant lie that FML never had his contract copy and work permit. FML always had a copy since they are the one who applied for the work permit not me nor maulana Patel and I have got documentary evidences on that.
- 13- Yes this was approved by Nasinu Branch League that I Feroz Gulam Mohammed was to pay the wages of maulana. He should refer to the minute book for detailed information.

- 14- On the issue of court proceedings I will write on this issue later but yes I have full right o keep all properties of the league in my custody but I have obeyed all court ruling and have delivered as I was told to do so.
- 15- The Chairman of Uloom Board Qaiyum Khan has been labelled as the founding father of munafiqs of the corrupted regime of FML. Qaiyum Khan has a long history of being the cause of disagreements between the two major groups Jaamatees and milaadees and if you pick any ordinary Muslim he will have at least 10 bad things to say about Qaiyum Khan.
- 16- Why a new contract when there was already a contract present. I again confirm that there is copy of contract with the Immigration department which I have sighted with my eyes and for that I have got three witnesses.
- 17- On the matter of the immigration director he is a liar, corrupt, a racist and biased person. It is the court who will decide and he will serve a lot of time of his life in jail in the near future.

Brother Maulana Imran Patel was only punished for nothing and of course Allah (SWT) will justify things in his own way. Abdul Hakim and his team are declared Munnafiqs or even worse and we will not leave them alone, we will fight until such time we liberate Fiji Muslim League from these munafiqs or if can't do that we will at least break away the affiliation of Nasinu Muslim League with Fiji Muslim League Insha-Allah. Maulana Imran Patel is most learnard and has done far more than he was suppose to during his stay and there are already four organisations who are negotiating with me to bring him back under the same banner of FML and if Allah wills he will be here no matter Villiame Naipoto is the director or whoever. **It's not me its Allah (SWT) who has promised and of course Allah (SWT) will fulfil his promises on the day of judgement that all munafiqs will be the partners of Abu-lahab and will never be forgiven. This regime will be finished and all these corrupted officials will be in their graves in the near future Insha-Allah and the fact remains if one mujahid dies Allah (SWT) will send 10 more.**

Brothers make many copies and give this email to brothers and distribute in masjid. Give a copy of this to Abdul Hakim aswell. I challenge Abdul Hakim if he speaks the truth then call a council meeting where I will prove him wrong Insha-Allah.
