### RE : PURCHASE OF VEHICLE

Dear Brother in Islam,  
*Assalamu Alaikum Rahmatullahi Wabarkatuhu*

We received your letter on the vehicle purchase for Dawah and tableeqi works based at Koronivia Jame Mosque.

First there is a correction that as we stated that " payment of vehicle was made from mosque account" . Please correct that the payment was made from the **General Account and there is no mosque account.**

Funds in the general account of Nasinu Branch are 60% by brothers who promote tableeqi therefore funds received from those brothers subject to be used in specially tableeqi and dawa. Management of Nasinu Branch has got authority to make such decision of purchase of assets on behalf of members of Nasinu and only Council has got right to over rule.

Now, as for Br. Asgar Ali's action is not justified and he should have lodged official complain to Branch first and moreover your brothers are entertaining this bypass action. We still do not know what his complain is about , but we only know that when he lost SDL election he swore to tableeqi brothers for not supporting him.

Please do not forget that BR. Asgar Ali is part of funds misused in 2006 from our college account. Please stop bypassing and using some sick brothers against us. The Islamic Affairs Board has no right to interfere in the purchase of said asset.

Most of the Molvies are there for financial gain and why cant they speak against:


1. FML involvement in interest

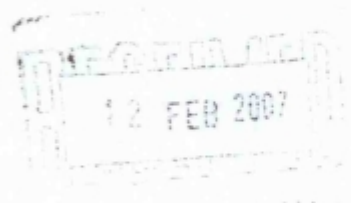

The vehicle is imported under FML and will also be registered under FML Headquarters.


The vehicle costed \$11000.00 VIP and of which \$3000.00 was donated and a payment of \$8000.00 will be made from our Mosque account.
