It seems (with whose authority, we do not know) you have prepared another financial account and dis regarded the original full financial accounts prepared by our Management for your auditing purposes.





This sort of conversation is very embarrassing and unwarranted.

**RE: FINANCIAL ACCOUNTS FML- NASINU BRANCH 2006**

Dear Brother in Islam,  
*Assalamu Alaikum Rahmatullahi Wabarkatuhu*

As discussed we received a copy of 2006 Financial account from A. Mishra & Co. and also note till to date our Treasurer MR. Mohd Hanif failed to present account and failed to attend last 7 Management Meetings.

We have written earlier to the auditor our concern but the auditor refuses to discuss any matter with the Management.

As the Constitution of FML clause 105-F and G and clause 26 of Branch Rules only allows Branch Management to compile, authorize and present full financial account of the Branch to the AGM. If we failed to do so, discipline action will be taken against us by members of Nasinu Branch.

Under the current Council Ruling on Board of Governors there are rulings that BOG are responsible to carry out full financial audited account. 2006 full financial audited account presented to us are separate accounts which was instructed and authorized by the Chairperson and other BOG members.

Our Management does not accept the account presented by the auditor and there is no way members at Annual General Meeting will accept the current separate format account (history will be create if our Branch present two Balance sheets) .

What we are requesting is either if you please instruct the auditor to present one balance sheet for Nasinu branch or arrange a Special meeting where members of BOG, A.Mishra & Co., Nasinu Management and FML Management( yourself) so we could discuss and solve this matter.

Also note that Mr. Abdul Hakim (chairperson of BOG) has given a written authority to forward these unapproved accounts to Ministry of Education which was to be approved in AGM but due to delay of our AGM this should have been discussed in our Executive before forwarding to education department. This was not being done.

We have gone through the account orally and have come across some disputes. Once our account with one balance sheet is presented then it will be discussed in Management then we will forward errors for final copy of Nasinu Branches account for 2006.
