Dear Brother in Islam,

Assalamu 'Alaikum Warahmatullahi Wabarkatohu

Pursuant to the Constitution of the Fiji Muslim League, I, as the Secretary of the Fiji Muslim League, Nasinu Branch, give notice that on behalf of the our branch, I intend to move the following motions at the next National Council Meeting or so soon as the circumstances of the situation permits:-

MOTION # 1

That in accordance with the Resolution passed at the last Annual General Meeting 2005 of Fiji Muslim League Nasinu Branch, that the Board of Governors be removed and replaced by the Board of Education as stipulated in the Constitution of the Fiji Muslim League.

MOTION # 2

That the Board of Executives shall confine itself to the Administration of Education System only and for the academic excellence of our children.

MOTION # 3

That all time Nasinu Branch of Fiji Muslim League shall control and manage the Financial affairs of the Branch.

MOTION # 4

That all scholarship either offered by National Officials of the Fiji Muslim League or either granted by the External bodies for the Muslim children must be equally distributed to all the Branches and therefore the branches shall nominate the recipient student(s) from that particular Branch.

MOTION # 5

That in view of the fundamental importance and the role that the ULMA Board entails with our Islamic System, the Chairperson / Secretary of the ULMA Board shall be appointed by the Board itself without any interference of what-so-ever from any source.

MOTION # 6

That the pursuant to the Resolution of the Annual General Meeting of the Fiji Muslim League held at Rakiraki in 2006. It was resolved that the National board of Fiji Muslim League shall provide to each Branch the Audited Accounts of:-

- (a) Education Trust Account
- (b) Fitrana Account
- (c) Investment Fund Account
- (d) Islamic Development Bank Account
- ✓ (e) Samabula Mosque Account
- (f) Zakaat Account


That Fiji Muslim League has failed to provide the above accounts and that Nasinu Branch of Fiji Muslim League moves that Fiji Muslim League direct their President/ Secretary/Treasurer to provide the above audited accounts without any delay and that the failure to do so shall be the ground for the suspension of the Executives of Fiji Muslim League.

MOTION # 7

That Nasinu Branch of Fiji Muslim League in view of the money collected by the Officials of the Fiji Muslim League from Islamic Development Bank for the shopping complex demands the following:

- (a) The total amount collected and the name of the currency
- (b) Provide evidence of the original documents
- (c) Provide evidence of the receipts given by the Officials
- (d) The bank or banks where any transaction with recipient to the money collected has taken place either in the form of exchange to Fiji dollars currency or from Arabian to U.S.A or any other currency.
